Election for members of Raipur Branch of CICASA of ICAI will be held on **Saturday, 31st December 2011** at 11.00 A.M. to 2:00 P.M. at Raipur Branch premises A-21, 1st floor, Mahavir Gaushala, Moudhapara, Raipur for forming of managing committee of Raipur Branch of CICASA of ICAI to hold office for the term 2011-2012.

The election of the Managing Committee of Raipur Branch of CICASA of ICAI comprising of six(6) members. The election shall be conducted by poll of members present at the meeting. No proxy shall be allowed.

Every student who is a member of Raipur Branch Student Association on the 1st day of April 2011 shall be entitled to vote provided he continues to be member on the date of election i.e. 31st day of December 2011.

Any member desirous of standing for election shall submit a nomination to the Chairmain, Raipur Branch of CICASA of ICAI. The nominations forms are available at branch premises on all working days from 7th December 2011. The nomination form can be submitted on or before 27th December 2011 at the office of Raipur Branch. Each nomination shall be accompanied by fee of Rs. 10/- which will not be refundable under any circumstances.

The last date for withdrawal of nominations will be 29th December 2011. The names of the valid contestants will be displayed on the Branch Notice Board.

The names of the candidates elected shall be announced by the chairman after election and his declaration shall be final.

Note:-

1) QUORUM

If within half an hour from the time appointed for the meeting a quorum is not present, the meeting shall stand adjourned to the same day in the next week at the same time and place at every such adjourned meeting the member present, whatsoever their number, shall have power to transact all the business which could properly have been transacted by the original meeting, had the necessary quorum been present thereat.


2) Eligibility for Stand in Election:-

Every Student who is a member of Raipur Branch Student Association on the 1st day of April 2011 shall be eligible to stand for election to the managing Committee of the student's association provided the un-expired period of training is not less than 12 month as on 16th September 2011.

3) Member of Raipur Branch Student Association:-

Any Article or Audit clerks residing in the Raipur & within 16 Kilometers from the municipal limits of Raipur is a member of Student Association of Raipur Branch.
