## UNDERSTANDING GST

GST is a value added tax, levied at all points in the supply chain with credit allowed for any tax paid on inputs acquired for use in making the supply. It would apply to both goods and services in a comprehensive manner with exemptions restricted to a minimum.

GST will be a game changing reform for Indian economy by developing a common Indian market and reducing the cascading effect of tax on the cost of goods and services. It will impact the Tax Structure, Tax Incidence, Tax Computation, Tax Payment, Compliance, Credit Utilization and Reporting leading to a complete overhaul of the current indirect tax system.

### SALIENT FEATURES OF GST

The power to make laws in respect of supplies in the course of inter-State trade or commerce will be vested only in the Union government. States will have the right to levy GST on intra-State transactions including on services.

The GST structure would follow the destination principle. Accordingly, imports would be subject to GST, while exports would be zero-rated. In the case of inter-State transactions within India, the State tax would apply in the State of destination as opposed to that of origin.

Centre will levy IGST on inter-State supply of goods and services. Import of goods will be subject to basic customs duty and IGST.

Central taxes like, Central Excise duty, Additional Excise duty, Service tax, Additional Custom duty and Special Additional duty and State level taxes like, VAT or sales tax, Central Sales tax, Entertainment tax, Entry tax, Purchase tax, Luxury tax and Octroi will subsume in GST.

Petroleum and petroleum products i.e. crude, high speed diesel, motor spirit, aviation turbine fuel and natural gas shall be subject to the GST on a date to be notified by the GST Council.

Entertainment tax, imposed by States on movie, theatre, etc will be subsumed in GST, but taxes on entertainment at panchayat, municipality or district level to continue.

Stamp duties, typically imposed on legal agreements by the state, will continue to be levied by the States.

Administration of GST will be the responsibility of the GST Council, which will be the apex policy making body for GST. Members of GST Council comprised of the Central and State ministers in charge of the finance portfolio.

The advantages of GST are:

1. Wider tax base, necessary for lowering the tax rates and eliminating classification disputes
2. Elimination of multiplicity of taxes and their cascading effects
3. Harmonization of center and State tax administrations, which would reduce duplication and compliance costs
4. Automation of compliance procedures to reduce errors and increase efficiency

# NEWS & UPDATES

## **Applicability of Income Computation and Disclosure Standards notified under section 145(2) of the Income-tax Act, 1961 from Assessment Year 2017-18. - (08-07-2016)**

The Central Board of Direct Taxes has vide Press Release dated 6.07.2016 clarified that the Income Computation & Disclosure Standards shall be applicable from 1.4.2016 i.e. previous year 2016-17 (Assessment Year 2017-18).

The Direct Taxes Committee of ICAI made detailed representation to Central Board of Direct Taxes during the Direct Tax Workshop with CBDT which was followed by written representation to Chairman, CBDT on 31.03.2016 and Hon'ble Finance Minister, on 7.04.2016 for deferment of implementation of ICDS. The representations made by ICAI were considered positively.

Thus, due to the efforts of the ICAI, the concerns of the stakeholders were addressed and applicability of ICDS stands deferred by 1 year.

## **Change in syllabus under the Revised Education and Training Scheme**

Number of queries are being received from the students with respect to the proposed change in the curriculum of Education and Training of CA course as to what will happen if registration is done under the Existing Scheme.

Students may please note that on completion of the whole process relating to the implementation of the Revised Scheme, an "Announcement" would be made about transition scheme for the existing students.

In view of the above, students are advised not to get misguided by information getting spread from unauthenticated sources. They may continue to register for the course at various stages, i.e. CPT/IPCC/Final in the normal course.

## **CA Students participation in Institute Programmes for 5 hours - (27-06-2016)**

The Council of the Institute has decided to implement a minimum of 5 hours (1 day) participation, in a year, w.e.f. 1st July, 2016 on recommendatory basis in various Institute's programmes organized by Board of Studies, Regional Councils and Branches during each year of Practical Training (Articleship period). This will be in addition to Orientation / GMCS / ITT courses of the Board of Studies (BoS).

To fulfil the requirement the students are advised to participate / attend in National Conventions/ Conferences/ Conclaves/ Regional/ Sub-Regional Conferences and other seminars, Study Circle Meetings, Elocution Contest/ Quiz Contest etc. or any other programme as may be approved by BoS. Principals are requested to facilitate at least the minimum interactive hours during each year.

The students shall be required to submit a self-declaration regarding their participation/attendance after completion of each year from the date of commencement of their Practical Training, within three months, to the respective DCOs under which they are registered either by email or registered mail.

## **Online Ordering of Publications**

Anyone interested can generate their own account including that of dashboard on this portal so as to have a record of all transactions made therein past and present.
